- 3. Attach an official transcript of college or university grades. If you're a high school senior and an official transcript of your high school grades are not yet available, a high school counselor must verify and certify the accuracy of the stated GPA by signature and date (see application).
- 4. A copy of actual ACT or SAT score report. (Only ACT/SAT reports will be accepted.)

\*If letter of reference or essay exceeds word limit, the entire application will be rejected. Incomplete applications will be eliminated prior to the selection process.



#### **General Rules**

- 1. Scholarships are available in the amount of \$2,000. One half of the scholarship is awarded at the beginning of the fall semester and the remaining one half is awarded at the beginning of the spring semester.
- 2. Scholarship funds shall be directly disbursed to the institution for payment of tuition, fees required for books, supplies and/or equipment required for courses of instruction.
- 3. Actual funding of each scholarship will occur after the cooperative receives an official copy of the student's registration for the semester. Students must maintain a minimum of 12 semester hours or be considered a full-time student by the registrar of a technical or trade school. Scholarship recipients are responsible for requesting these funds each semester.
- 4. If a recipient's cumulative GPA falls below 2.5 or if the recipient fails to register as a full-time student for the spring semester, recipient will be placed on probation for one semester. If probationary issues are not corrected within the following semester, the remaining scholarship funds allotted to that student (\$1,000) will be revoked. If the recipient fails to enroll or register for any course work during the spring semester, the remaining scholarship funds allotted to that student (\$1,000) will be revoked.

### **Eligibility Requirements**

- 1. The applicant must be an active Concho Valley Electric Cooperative member whose primary residence is served by CVEC **or** be the dependent of a CVEC member whose primary residence is served by CVEC. The member must be in good standing for at least twelve (12) consecutive months as of the application deadline.
- 2. Recipients will be chosen based on the following criteria: grades, leadership, community, school activities and essay.
- 3. The recipient must attend a recognized Texas institution of higher education, including certified trade schools, while pursuing a degree at any level.
- 4. Completed scholarship application and all required documents must be received no later the last business day of March of each year.
- 5. Graduating high school seniors must have maintained at least 80 percent on a 100 percent scale.
- 6. Students currently enrolled in post-secondary education course work must have maintained a minimum cumulative of 2.50 GPA on a 4.00 scale at an accredited four-year university/college, junior college, or TEA-approved trade school.
